a. Processing Your Health Data

Please submit all your medical data documents, including sick leave, disability and pregnancy reports, directly and solely to the occupational physician. Such documents and information will not be received by the Human Resources Directorate in accordance with the efforts to comply with the law.

b. Processing of Your Data on Criminal Convictions and Security Measures

If you provide your informed consent regarding your data on criminal convictions and security measures (especially including information of criminal record), the data will be processed by Kent for the purposes of ensuring the safety of the operations of the data controller, implementation and management of occupational health and safety activities, and conduct of the executive activities, and for the realization of the above-mentioned purposes, the data will be transferred to limited number of necessary authorized persons, institutions and organizations only when requested.

In accordance with the Article 11 of the Law regulating the rights of the persons concerned, you may submit your requests for the processing of your personal data to Kent in accordance with the Communique on Principles and Procedures to be Followed for the Request to Data Controller.
